Using the trademark

Use the correct form when using PlayStation®Plus in running text, or in other text such as titles and headings.

Correct usage

Use a plain, non-stylized font. Distinguish the trademark by adding the registered trademark symbol ® or by enclosing it in double quotes.

Note

The use of all capital letters is allowed on exceptional basis only when the trademark is used in a section where all words are in all capital letters and the impression of the trademark is weakened if shown with lowercase letters.

Incorrect usage

Using the abbreviation

When using the PlayStation®Plus trademark multiple times within one document, one page, or one panel, the full trademark must be used for the first or most prominent reference. The abbreviation PS Plus can be used for subsequent references.





Size

The minimum size of the logo is shown below. If the logo cannot be clearly represented at this size, use the smallest size at which the logo can be clearly represented*.

*Trademark symbols (®,TM) within the logo can be deleted only if the logo is so small that readability is compromised. Enlarging the trademark symbol portion only is also allowed. Do not modify the icon even if the TM symbol within the icon becomes proportionately smaller.

Maintain sufficient space around the logo and avoid placing any other elements within the isolation zone, as shown below.



Do not change the shape.



Do not change the proportions.



Do not change the placement of the ® symbol.



Do not use outlined fonts.



Do not add shadows.



Do not use two or more colors.



Do not add special effects.



Do not add gradations.



Examples of incorrect logo usage

The following are examples of incorrect logo usage.

Do not combine with other shapes or text elements.



Do not display two or more identical logos on the same surface.



Do not use the logo as a background design element.



Do not display the logo with low contrast relative to the background.



Do not display the logo on a complex background.



Do not display the logo on other figures or graphic images.



Do not display a cut-off or partial logo.




Authorized forms and color representation

As a general rule, use colored icons. Note that use of colored icons is strongly recommended for full-color displays.
For displaying the icons defined as silhouette, follow the guidelines below.



Display color of the icons defined as silhouette

- Color of the icons:
A single basic color or secondary color on next page. You must not use other colors.
- Color of \triangle \circ \times \square in the icons:
For using transparent \triangle \circ \times \square , ensuring full visibility is needed.
When using a single color, we strongly recommend background color, similar color of background, or white.

The single-colored PlayStation®Plus icon must always be displayed in one of the colors listed below. You must not use other colors.


Size / Isolation zone

Follow the guidelines below to use the icon correctly.

Size


The minimum size of the icon is shown below. If the icon cannot be clearly represented at this size, use the smallest size at which the icon can be clearly represented.

Do not modify the PlayStation®Plus icon even if the TM symbol within the icon becomes proportionately smaller.



Isolation zone

Maintain sufficient space around the icon and avoid placing any other elements within the isolation zone, as shown below.

Using the icon as part of the background

Displaying the icon multiple times on a surface, trimmed and used on isolation zones. Do not use a TM in these cases.

The icon partially extends past the display area. Do not use a TM in this case.

Examples of incorrect icon usage

The following are examples of incorrect icon usage.

Do not change the proportions or shape.



Do not add too much transparency.



Do not change the placement of the TM symbol.



Do not add special effects.



Do not use non-defined colors.



Do not use two or more colors.



Do not combine with words or trademarks misunderstandings.



Do not replace $\triangle\circ\times\square$ in the icon with other shapes or text.



Do not place the icons have transparent $\triangle\circ\times\square$ on background images or animations that reduce visibility of the mark.



Using trademark notices

Trademark notices must be included in the same material containing the trademark and logo. The logo must be in the correct trademarked graphical form, not in the running text font.

Trademark notices for PlayStation®Plus

(1) When using PlayStation®Plus in running text:

“PlayStation” is a registered trademark or trademark of Sony Interactive Entertainment Inc.

(2) When using the PlayStation® family mark, the PlayStation®Plus logo, and PlayStation®Plus in running text:

“” and “PlayStation” are registered trademarks or trademarks of Sony Interactive Entertainment Inc.

(3) When the PlayStation®Plus icon is added to (2):

“”, “PlayStation” and “” are registered trademarks or trademarks of Sony Interactive Entertainment Inc.
